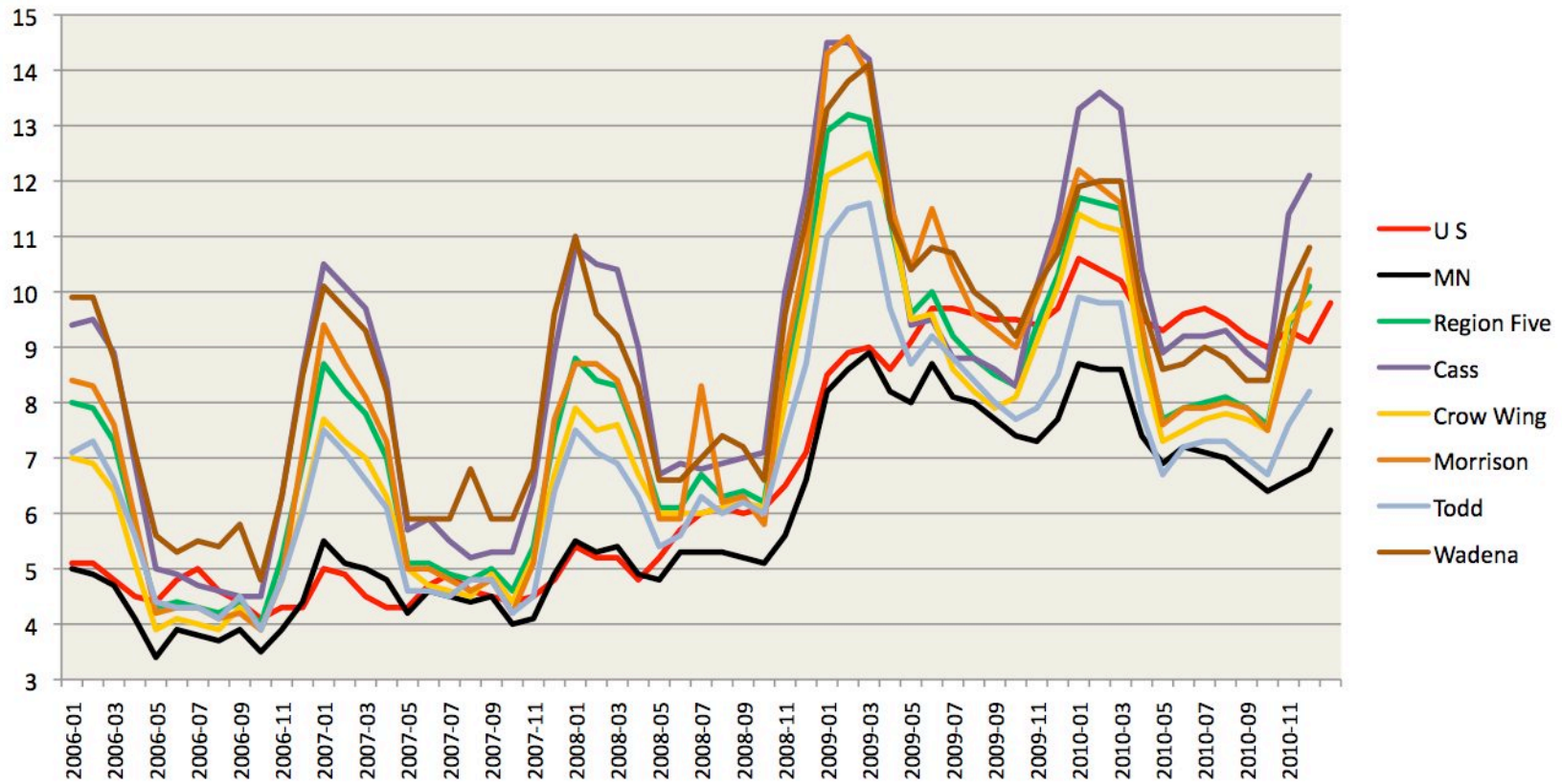

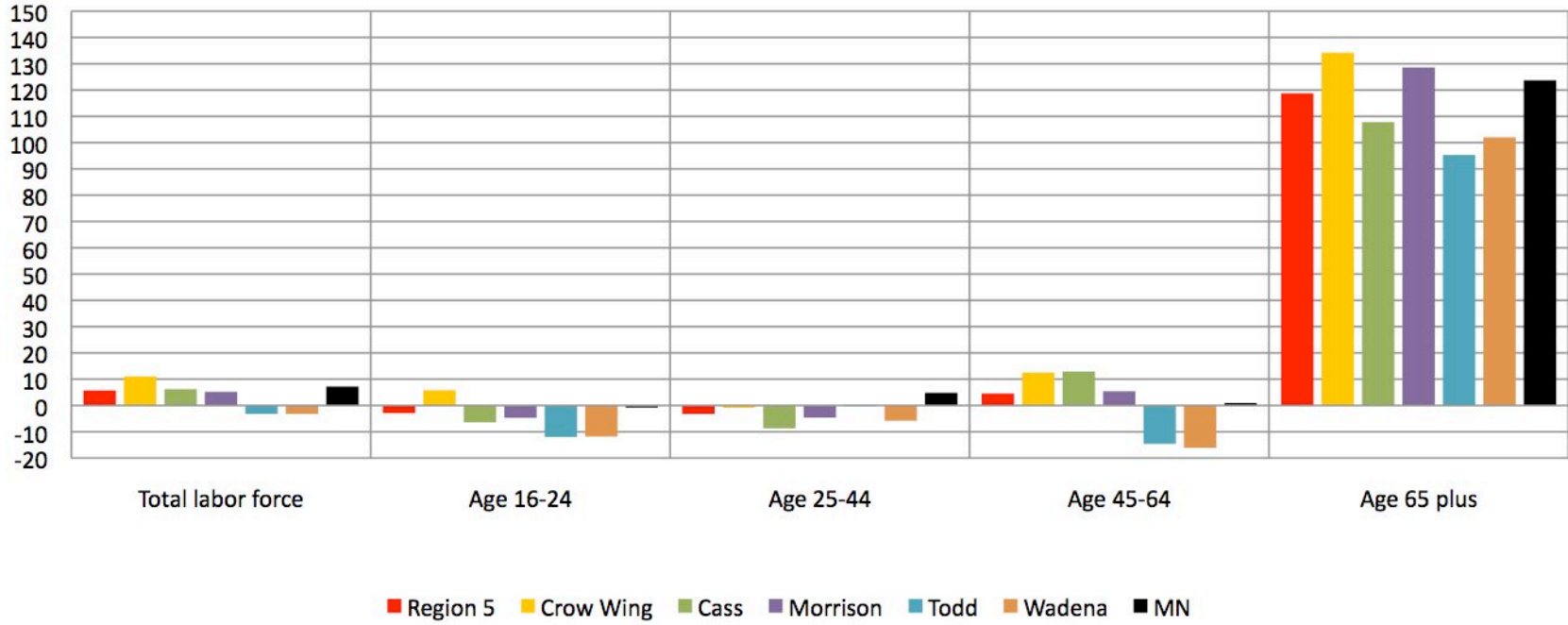

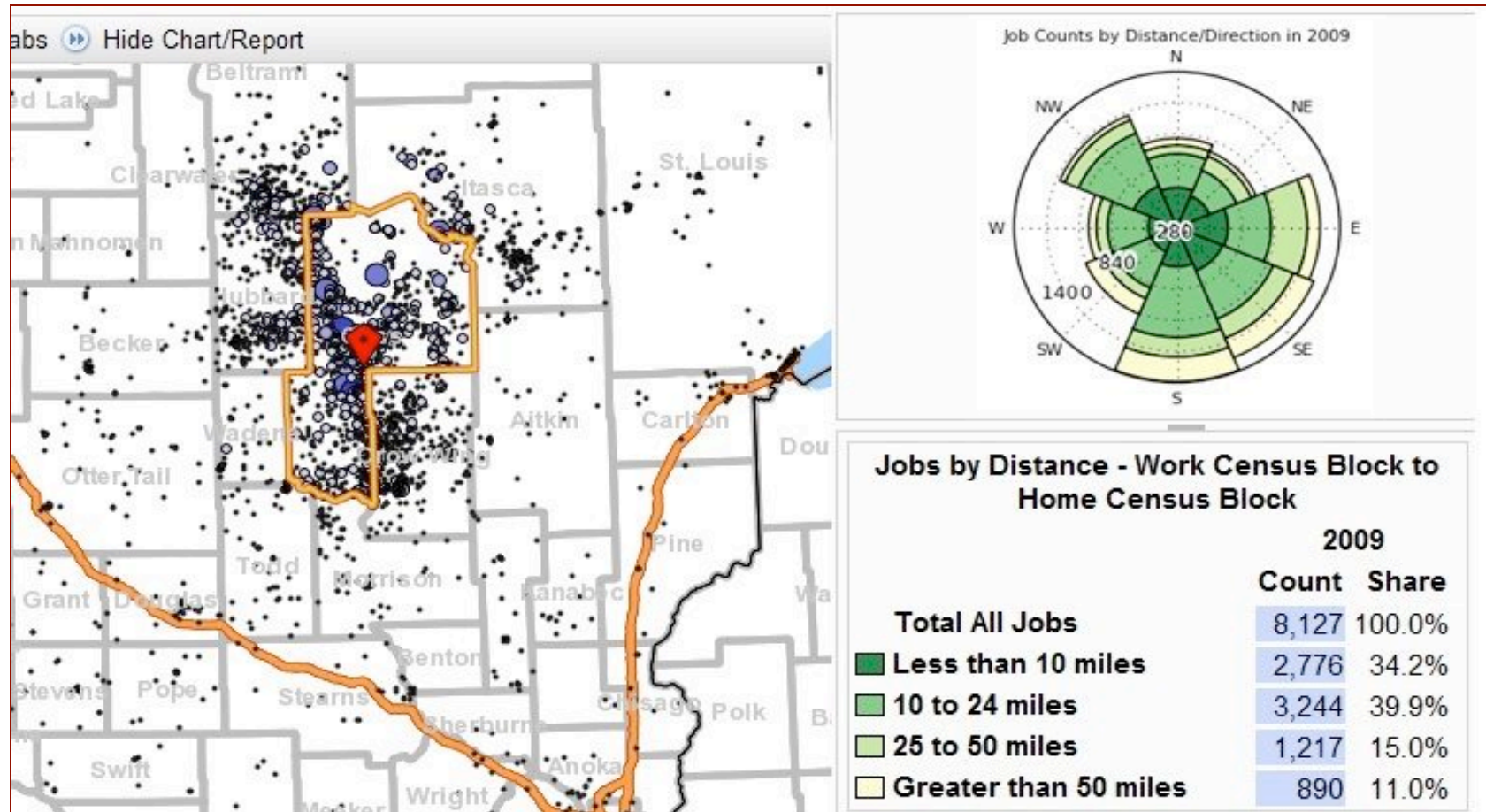

Commute Shed – Where County Residents are Working

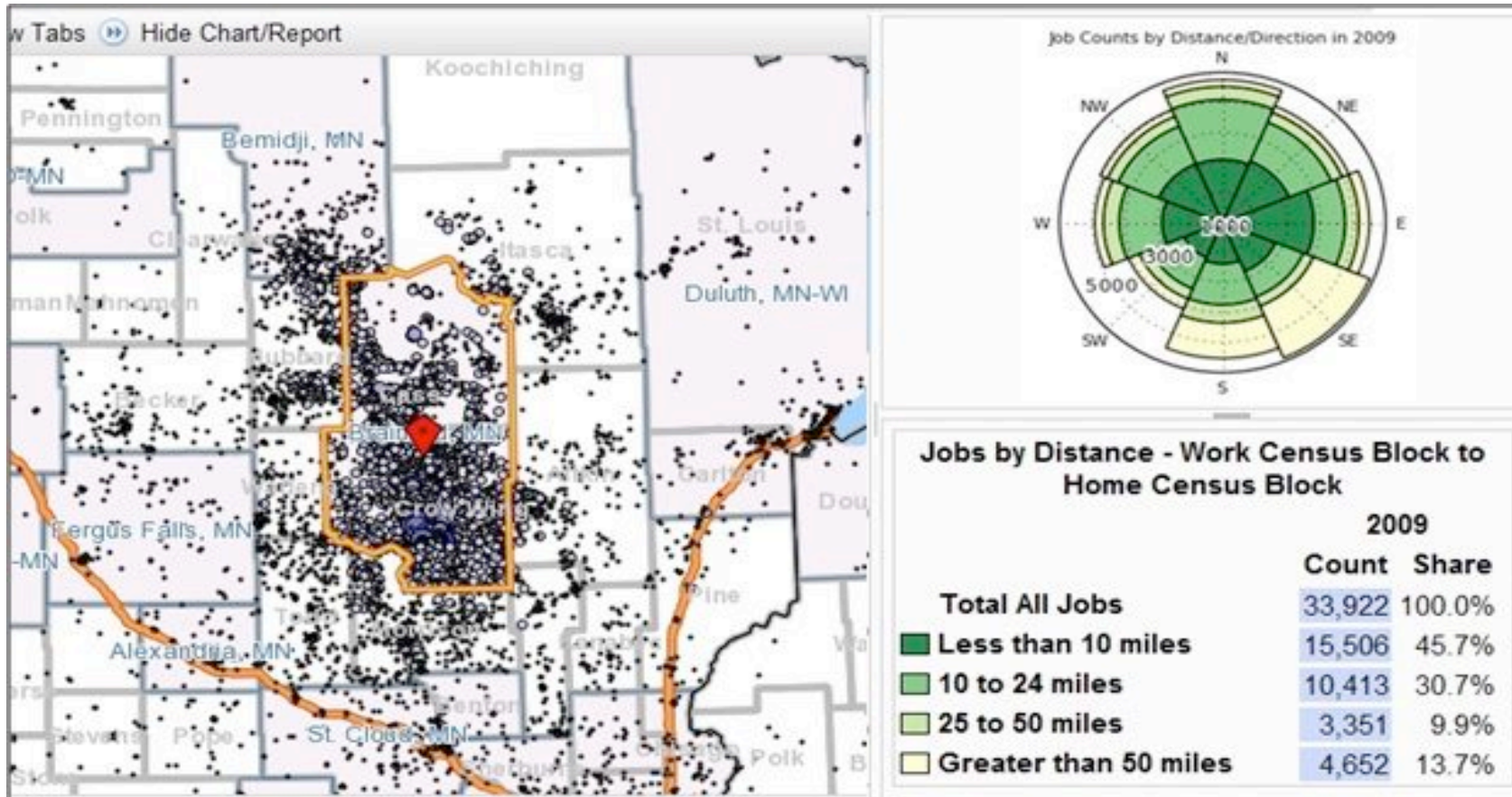
Cass County Commute Shed

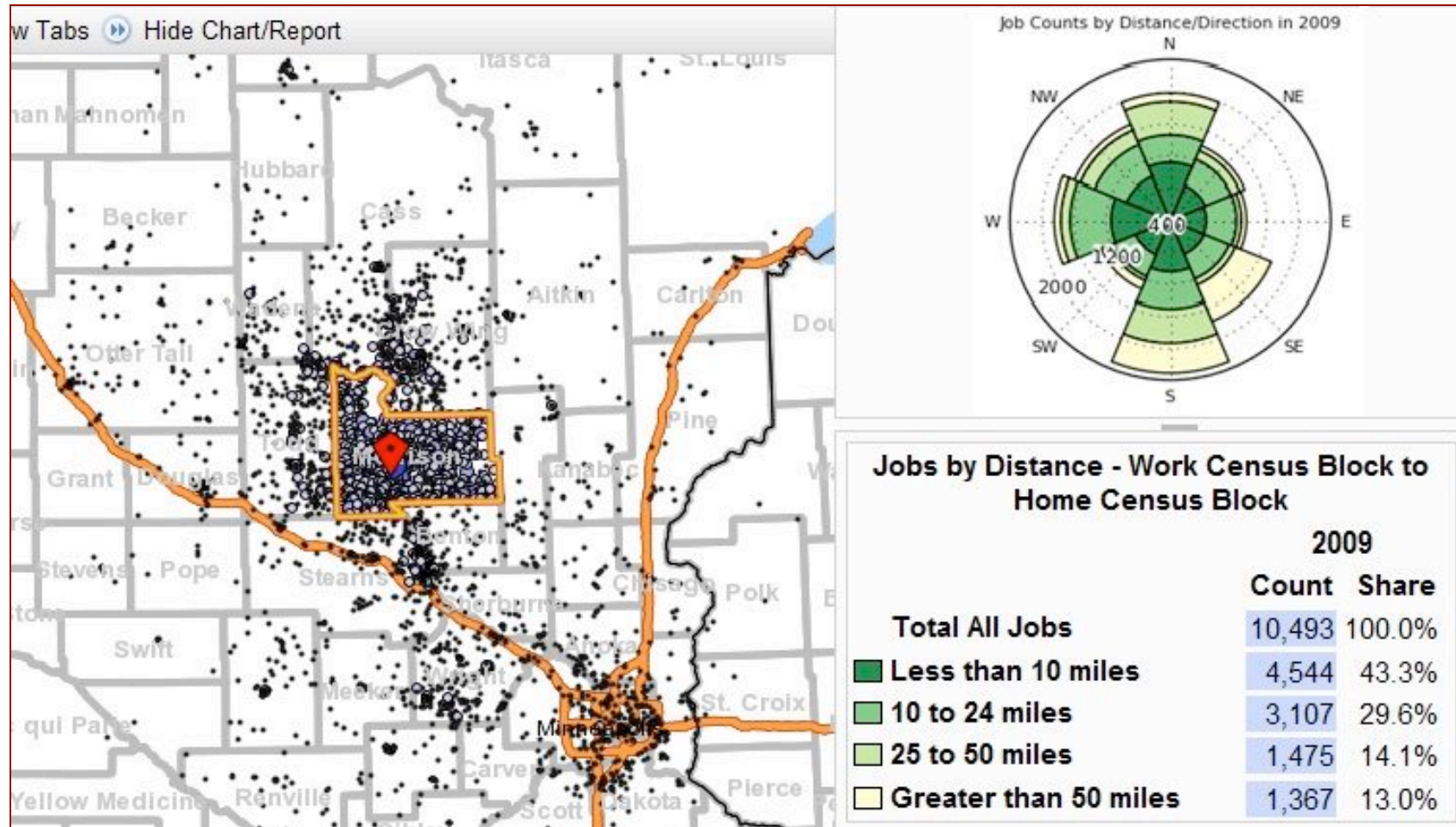
Brainerd-Baxter Micropolitan Area (Crow Wing Co)

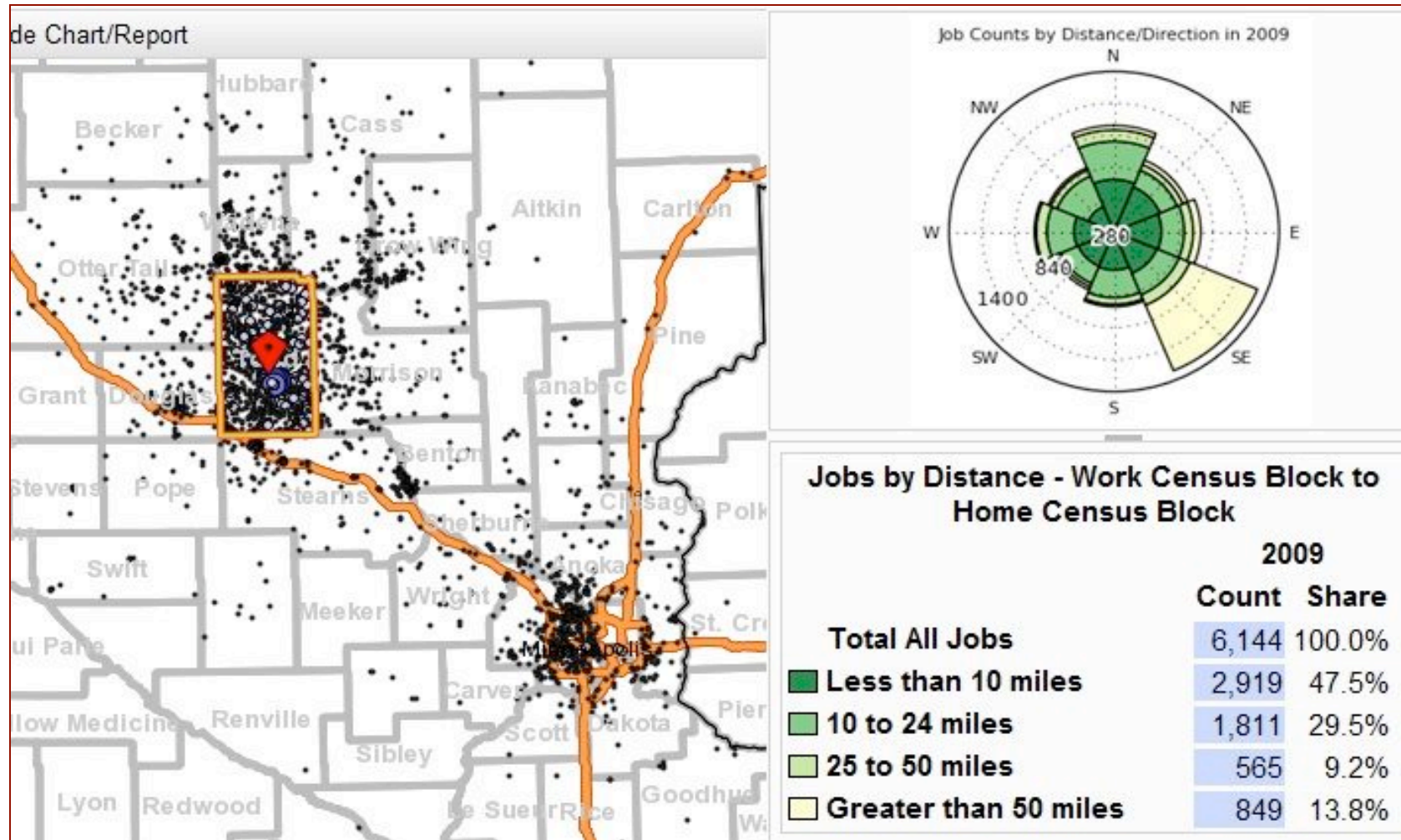
Morrison County Commute Shed

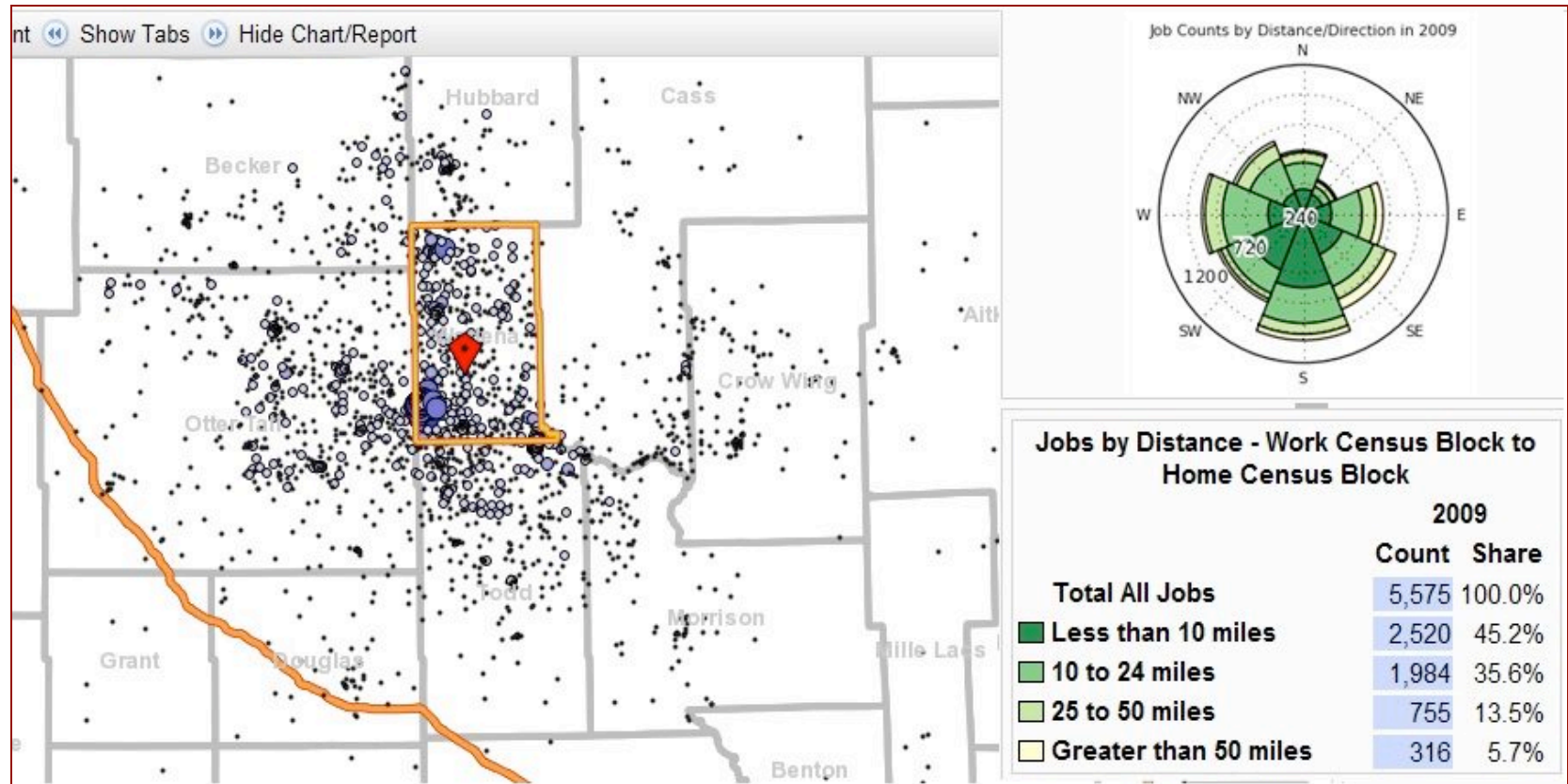
Todd County Commute Shed
